CAMP RED ARROW EXPECTATIONS AND DRESS CODE To be read & signed by all

- Have a personal, growing relationship with the Lord Jesus Christ, seeking to serve Him to the best of your ability.
- Be at camp by 7:00 PM on the Sunday night before your week of camp begins. All staff will meet at 7:30.
- Abide by the dress code.
- Remain after the campers are dismissed on Friday night in order to help clean up the camp and prepare it for the next week. After a clean-up inspection, all **Senior staff** will meet to evaluate the camp week before dismissing.
- Perform the tasks assigned to you without complaining and to the best of your ability. Don't wait to be told what to do, but if you see something that needs to be done or others who need help, take initiative and pitch in.
- Assist the lifeguards by keeping your eyes on the campers in the pool.
- Go to the Camp Director with any complaints or problems. Do not cause disunity by gossip or complaining.
- Only Senior Counselors and Full-time staff are allowed to have their cell phones in their possession. Other staff members will need to turn in their phones at the camp office. They will be allowed to access them at designated times.
- T.E.A.M. members and Jr. counselors/staff are not allowed to stay at camp over the weekend.

DRESS CODE

SHIRTS

To be fair and to simplify the dress code, only t-shirts or button-up shirts are allowed.

No tank tops or sleeveless shirts. No V-necks.

Shirts should cover the waist when arms are raised.

They should not contain or portray any suggestive or derogatory pictures or messages.

Guys need to wear shirts at all times except in the cabin, pool, or bathhouse.



SHORTS/PANTS/SKIRTS

Shorts should be modest, to the top of the knee, and loose-fitting.

Jeans or pants should not be tight-fitting.

Skirts and dresses should be no shorter than the knee.

SWIMSUITS

One-piece swimsuits with modest necklines are required for girls or two-piece suits that cover like a one-piece. All campers must wear t-shirts or cover from the pool to their cabin or the bathhouse.

REASONS FOR THE DRESS CODE:

In life, we have three enemies, the World, the Devil, and the Flesh. After Adam and Eve sinned, we were all born with a sin nature, which is the flesh. Camp Red Arrow is a Christian camp and as such we are striving to provide a "safe" place not only physically, but spiritually. We want to minimize fleshly distractions in order to promote spiritual growth.

- We try to keep out the world's influence by limiting access to the media (no radios, TV, etc. allowed).
- We are looking for godly staff members, not perfect people, but those who truly love God more than the world.
- By dressing modestly, we provide an atmosphere that helps us not to focus on the flesh, but on God.

Our overall desire is to bring glory to God and point attention to Him and not to bring undue attention to ourselves.

CBM DOCTRINAL STATEMENT

While Children's Bible Ministries, Inc. serves along nondenominational lines, there are certain essential truths which we believe.

WE BELIEVE:

- A. The Scriptures of the Old and New Testaments to be verbally inspired and inerrant in their original writings.
- B. In the deity of Jesus Christ as fully God and fully man.
- C. In man's fallen sinful condition.
- D. Jesus Christ offered on our behalf the only acceptable sacrifice for sin and was raised in the same body from the dead.
- E. That repentance, forgiveness, and becoming a new creation are several of the many experiences of the Christian who is kept by God's power and is secure in Christ forever.
- F. That God, The Holy Spirit, is a person who convicts sinners, and who regenerates and baptizes them at the moment of their salvation into the Body of Christ.
- G. In the personal return of Jesus Christ for His Church.
- H. In the bodily resurrection of the saved and the lost.
- I. That Christ made provision for all the effects of sin in the atonement and that God heals according to His sovereign discretion.
- J. That the purpose of spiritual gifts is for the edifying of the Church and the propagation of the Gospel. We believe that speaking in tongues, miracles, and the raising of the dead were to authenticate new revelation.
- K. God sovereignly and immutably creates each person as a male or female. These two distinct, complementary genders together reflect the image and nature of God and His plan for man and woman.
- L. In the Biblical view of marriage as sanctioned and defined by God in His Word, which is the exclusive, covenantal union between one man (born biologically man) and one woman (born biologically woman).

CHILD ABUSE PREVENTION STATEMENT

"It were better for him that a millstone were hanged about his neck, and he cast into the sea, than that he should offend one of these little ones. Take heed to yourselves ... " Luke 17:2-3a

I, the undersigned, as a volunteer/staff member at Camp Red Arrow, a ministry of Children's Bible Ministries of Virginia, understand the following:

- Abuse is something that occurs in our society, unfortunately, even in Christian settings.
- I pledge to do everything in my power to prevent abuse. I further understand that I am prohibited from engaging in any form of abuse and will follow these policies to help prevent abuse and/or accusations:
 - 1. At no time will I be alone with a child where I cannot be observed by others.
 - 2. I will provide good supervision and never leave any child unsupervised.
 - 3. I will be alert to the physical and emotional state of each child in my cabin and report any signs of injury or suspected abuse.
 - 4. I will make sure that children never enter the restroom alone.
 - 5. I will not touch, tease, or otherwise make any child feel uncomfortable.
 - 6. I will never discipline a child by use of physical punishment such as spanking or depriving of a meal.
 - 7. I will not socialize with campers outside of the CBM program unless invited by parents to public gatherings/events such as church.
 - 8. I will not socialize with children by sleepovers, dating, etc.
 - 9. I will not transport children in my own vehicle.
 - 10.I will be a positive role model for the children and a reputable representative of the Lord Jesus, Camp Red Arrow, and CBM of Virginia, Inc.
- I am aware of the potential for child abuse, the importance of guarding against it, the signs of abuse, and the proper reporting procedures if a situation arises.
- I understand that reporting suspicious behavior is everybody's responsibility and that I will be held accountable to do so.
- CBM of Virginia is serious about doing everything it can to prevent abuse of any kind including physical, verbal, sexual, and mental abuses, and neglect.
- CBM of Virginia reports all cases of suspected abuse to the appropriate authorities and cooperates fully and in good faith with any investigations.
- In case there is an accusation of abuse, I am not able to discuss the issue. Only the designated CBM of Virginia spokesperson has the authority to do so.
